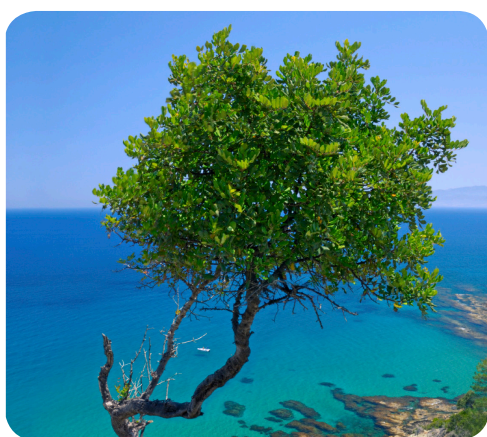

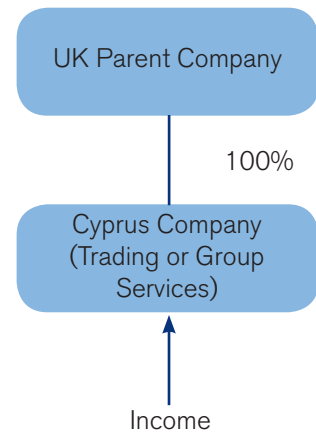

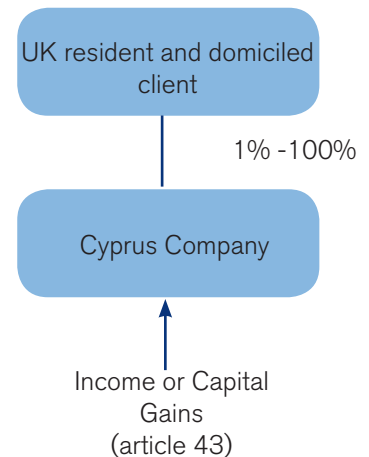
Post Cadbury Schweppes and Vodafone 2, a CFC apportionment charge of the Cyprus companies profits to the UK parent is precluded provided that the Cyprus company conducts genuine economic activity in Cyprus.

Comment

The European Treaty's fundamental freedoms of establishment and free movement of capital can be invoked to preclude s720 ITA 2007 or s13 TCGA 1992 charges. Again, it will be important that the Cyprus company conducts genuine economic activity.
